Sub: Closure Directions under Section 33 (A) of the Water (Prevention & Control of Pollution) Act, 1974 & under Section 31 (A) of the Air (Prevention & Control of Pollution) Act, 1981.

Ref: 1. Consent to operate granted by Board on 29/06/2021 valid up to 31/07/2024
2. Complaint received against your industry
3. Board official visited your plant on 10/05/2022
4. Office Note approved by competent authority dated 20/06/2022

WHEREAS, the Water (Prevention & Control of Pollution) Act, 1974 & Air (Prevention & Control of Pollution) Act, 1981 is applicable to the State of Maharashtra as declared in Official Gazette. AND, the area where your unit is situated, falls under the said declared area.

AND WHEREAS, it is obligatory on your part to provide adequate Water & Air pollution control arrangements so as achieve the prescribed standards under the Environment Act & Rules and not to cause nuisance in the surrounding area.

AND WHEREAS, complaint was received against your unit vide reference 1 above and Board official visited your plant to investigate the complaint. Based on visit report Sub Regional Officer, Mumbai – II has reported following non-compliances;

1. You have provided Water sprinklers provided as APC system were not found in operation during visit.
2. You have provided only partial barricading at around the periphery of the plot area
3. You have not provided Mechanical sweeper/industrial vacuum cleaner.
4. You have provided dust collectors at Silos but the same are found not in operation.
5. You have not provided adequate Effluent treatment plant & recycling system.

6. You have not provided adequate dust collection system at mixing section of cement, aggregate & sand.
7. You have not provided continuous ambient air quality monitoring station (CAAQMS) within premises as per consent condition.
8. You have not provided the details of submissions of Bank Guarantee.
9. You have not maintained the records as per consent conditions.


AND WHEREAS, after examining all the reports and records available with this office, I have come to the conclusion that you are knowingly and willfully violating the provisions of the Water (Prevention & Control of Pollution) Act, 1974 & the Air (Prevention & Control of Pollution) Act, 1981

NOW THEREFORE, in exercise of the powers conferred upon me by the Board under 33 (A) of the Water (Prevention & Control of Pollution) Act, 1974 & section 31(A) of Air (Prevention & Control of Pollution) Act, 1981, I, Regional Officer, Mumbai hereby direct you to stop your activities forthwith. It may also be noted that the competent authorities are being directed to disconnect the electricity and water supply to your unit.

In case, you fail to comply with these directions, the Board will have no option than to initiate further action including prosecution against you, which may be noted.

This direction is issued with approval of competent authority of the Board.
