**Sub:** Proposed Directions u/s 33A of the Water (Prevention & Control of Pollution) Act, 1974 and/or u/s 31A of the Air (Prevention & Control of Pollution) Act, 1981 and read with the Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2016

**WHEREAS**, you are operating your industry in Water & Air pollution prevention area declared under Water (P & CP) Act, 1974 Air (P & CP) Act, 1981 and Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016. AND WHEREAS, Board has granted consent to your industry subject to certain terms & conditions therein for necessary compliances.

**AND WHEREAS**, it is obligatory on your part to comply those conditions and provide necessary water & air pollution control devices and operate them continuously and efficiently so as to meet the standards prescribed by the Board at all times. Also comply with the Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016.

**AND WHEREAS**, The Board officials visited to your unit on 29/08/2019. During visit observed that, 1) Insufferable Nox fumes observed from vent due to wrong discharging of raw material causing incidence. 2) You have not informed incident immediately to Board. 3) You have not submitted details of disposal of MEE salts, details of high COD steam disposal to CHWTSDF. 4) You have not provided stack monitoring facility i.e. ladder, platform & port hole attached to process stack. 5) ETP found not in operation. 6) Alkaline seepage observed in storm water drain. 6) You have not provided separate energy meter for pollution control systems as per consent conditions.


**AND WHEREAS**, the above fact shows gross violation of consent conditions and clearly indicates your negligent attitude towards aspect of pollution control and Environment protection.

**NOW THEREFORE**, in exercise of the powers conferred upon me by the Board under section 33A of the Water (P & CP) Act, 1974 and under section 31 of the Air (P & CP) Act, 1981, I, hereby direct you as follows:

- a. Why your industry shall not be directed to close down its manufacturing activity forthwith?
- b. Why the competent authority shall not be directed to disconnect water / electricity supply to your unit?

- c. Why legal action shall not be initiated against you for violation of the provisions of the aforementioned Acts?

You shall remain present for personal hearing dtd. 27/09/2019 at 11:30 hrs along with reply to this direction and documents you want to rely upon, failing in which legal action will be initiated which may result in closure of your unit, which please note.
