WHEREAS, it is mandatory and obligatory on your part to abide the provisions made under Section 25/26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and Hazardous & Other Waste (Management & Transboundary Movement) Rules, 2016 for running your industrial activity at aforesaid location.

AND WHEREAS, you have submitted the application for renewal of consent to operate vide above ref. No 2., **AND WHEREAS**, Board has issued Show Cause Notice to the industry vide above reference cited at 4.


AND WHEREAS, the Board has refused your application for renewal of consent vide above ref. No. 6 due the following non – compliance

1. You have failed to recycle / reuse treated industrial effluent 100% in process and disposed on land for gardening purpose.
2. As Common Effluent Treatment Plant is not commissioned resulting in disposal of effluent on land which further deteriorate the quality of ground water.
3. You have not submitted the reply/compliance of Show Cause Notice issued vide reference Sr.no.(4).

AND WHEREAS, SRO – Nashik submitted the legal action proposal to this office vide above ref.No.6 **AND WHEREAS**, after examining the record of your case and after making necessary enquiry this office has concluded that you have failed to address the above issues which show your negligent attitude towards Environment Protections.

NOW THEREFORE, in exercise of the powers confirmed upon me by the Board, I Dr. P.M.Joshi, Regional Officer of the Board at Nashik hereby directed to stop production activity of the industry forthwith till further directions/order of the Board and the competent authorities are hereby also directed to disconnect electricity and water supply of the industry immediately, which may be noted.

This is issued with approval of Competent Authority of the Board.
