WHEREAS, it is obligatory on your part to obtain Consent to Establish and Consent to Operate from the Maharashtra Pollution Control Board under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under the provisions of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016. It is also obligatory on your part to provide adequate pollution control devices.

AND WHEREAS, the Board has received a complaint reg. Pollution caused by the industry.

AND WHEREAS, in order to verify the complaint or news, the officials of the Board at the unit. have visited the site at Gat no. 179/1, Mauje Chitepimpalgaon-431010, on 16/01/2024.and observed as follows:

- i. You are operating the industry without obtaining Consent to Establish and operate from Board.
- ii. You have not provided effluent treatment plant for effluent generated from your unit.
- iii. You are discharging the untreated effluent in the surrounding area.
- iv. You have not provided Air Pollution Control arrangement.
- v. You have not provided storage arrangement for tyre ash, and during the visit the tyre ash found lying haphazardly on over the premises.
- vi. You are not following the SOP for tyre Pyrolysis issued by CPCB.
- vii. You have not done tree plantation around your premises.

AND WHEREAS, the Maharashtra Pollution Control Board has issued proposed directions vide letter dated 04/03/2024 to you and directed to Show Cause as to ..

- a. Why your industrial activity shall not be closed forthwith?
- b. Why the competent authority shall not be directed to disconnect water/electric supply to your unit?

AND WHEREAS, in response to the proposed directions, you have failed to submit reply to the proposed directions within stipulated time.

AND WHEREAS, in spite of giving reasonable opportunity, after examining the record of your case and the reports of the officers of the Board, it has been observed that you are operating your unit without obtaining consent from the Board under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 and adequate pollution control devices, thereby discharging untreated effluent into the nearby low-lying areas nalla, discharging air emission without prior air pollution control system and thereby causing water/air pollution into the environment, affecting health of citizens.

NOW THEREFORE, in view of the above non-compliances, you are hereby directed to stop your manufacturing activities forthwith, failing which, the Board will have no option than to initiate appropriate legal action under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981.

It is not expedient and proper to give you further opportunity of hearing in view of earlier above sufficient reenable opportunities are given to you to comply with the provisions of Water Act & Air Act as well as Hazardous and other waste (Management and Handling) Rules 2016.

This direction is issued with the approval of Competent authority of Board.
