Sub: Interim Direction under Section 33A of the Water (Prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.

Ref: 1. Proposed Direction issued vide no MPCB/PD/2407160001 dtd 23/01/2024  
2. Personal Hearing extended on 29/07/2024.


The M.P.C. Board had issued Proposed Direction vide letter at ref. (1) to your industry under Section 33A of the Water (P& CP) Act 1974 and under Section 31A of the Air (P&CP) Act, 1981. As a principle of natural justice, a personal hearing was extended on 29/07/2024. During personal Hearing, issues related with pollution problems of your industry were discussed in detail. Considering your assurances to improve Environment in your industry, following Interim directions are issued under Section 33A of the Water (P & CP) Act, 1974 & 31A of the Air (P&CP) Act, 1981 for compliance.

1. You shall provide G.I. Sheet covering along with dust collection system at each dust emission source and material transfer point, within one month.
2. You shall provide automated water sprinkling with fogging arrangement (mist type) to the premises of RMC Plant, within one month.
3. You shall provide vacuum trucks within one month, for removal of dust deposited on road in factory premises.
4. You shall upgrade existing dust collection system provided to ash / cement silo, within one month.
5. You shall provide two level type washing system with ETP, within one month.
6. You shall provide CAAQMS in plant premises, within one month.
7. You shall provide closed shed at raw material storage area, within one month.
8. You shall submit Bank Guarantee of Rs. 1,00,000/- within 15 days, towards compliance of interim direction. If you have failed to submit B.G. within, stipulated time period will imposed 12% interest on B.G. as per Board Circular dtd 29/02/2024.

**In case, you fail to comply with the above Directions, the Board will have no option than to forfeit the Bank Guarantee and issue final directions as deemed fit in your case, along with suitable legal action which may please be noted.**
