Sub: Interim Directions under section 33A of the Water (Prevention & Control of Pollution) Act, 1974 and 31A of Air (Prevention & Control of Pollution) Act, 1981.

With reference to Proposed Directions referred at (2) above and subsequent personal hearing extended on 05/10/2023

Considering your reply and technical submissions during the hearing and Sub Regional Officer Pune-II report, you are hereby directed to strictly comply with the following Interim Directions,

1. You shall not carry out the production of Acoustic Insulation Products without consent to operate of the Board.
2. You shall store the hazardous and non-hazardous waste as per the Hazardous & Other Wastes (M & TM) Rule, 2016.
3. You shall operate a Sewage Treatment Plant so as to achieve consented standard and sludge generated from STP used as manure within the premises.
4. You shall not extract and use the ground water for your commercial activities and also take the water from CGWA Authorized tanker water supplier.
5. You shall operate and maintain the air pollution control systems so as to achieve air emissions standards provided at Ovens.
6. You shall provide carbon filters so as to minimize the emissions of gases to avoid the smell nuisance to vent of the ESP within 01 months.
7. You shall submit Bank Guarantee of Rs. 1,00,000/- (One Lakh Only) towards compliance of above directions. The Bank guarantee shall submit within 15 days in favor of Regional Officer, MPC Board, Pune.

You shall submit the action report on the above directions within 07 days. In case you fail to comply with the above directions the Board will have no option than to issue appropriate directions as deem fit under provisions of the Water (P. & C. P.) Act, 1974 and the Air (P. & C. P.) Act, 1981, which may please be noted.
