> Sub:- Proposed Directions under Section 33 A of Water (P & CP) Act. 1974 and Section 31 A of Air (P & CP) Act-1984.

Ref:- 1. Consent granted by the Board valid up to 30.06.2023.

2. Visit of Board officials to your unit on 19.12.2023.

WHEREAS, the Maharashtra Pollution Control Board has granted Consent to Operate u/s 26 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under Rule 6 of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016, on 02.12.2020 which is valid upto 31.08.2025 subject to certain terms and conditions.

AND WHEREAS, it is obligatory on your part to provide adequate pollution control devices and comply with the consent conditions so as to achieve the standards prescribed by the Board in its consent.

AND WHEREAS, the Board Officials at Ahmednagar visited your unit on 19.12.2023 for checking the compliance of consent conditions and observed that-

1. Not provided OCEMS to RO permeate line as per consent condition.

2. Industry has started expansion activity without obtaining consent to operate from the Board.

3. Industry has not disposed Non-H.W. to authorized party.

4. Contaminated waste water observed in storm water drain, due to which there is a chances of same may be going to outside the factory premises.

5. Leakages & seeppages observed near compound wall.

6. Not provided retro fitting of emission control Device as per circular dated 02/06/2023 to the DG sets.

7. Industry has not submitted BG of Rs.25.0 Lakh as per consent to establish condition dated 10/11/2023.

AND WHEREAS it has been observed that you have failed to comply with the conditions stipulated in the Consent granted by the Board.

NOW THEREFORE, in view of the above non-compliance, you are hereby directed to show cause as to:

- 1. Why your consent shall not be revoked?
- 2. Why your industrial activities shall not be closed down?
- 3. Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit?

Your reply, if any to these Directions shall be submitted within 15 days from date of issuance of this notice, failing which, the Board will have no any other option than to initiate further stringent legal action against your unit, which may be noted.
