WHEREAS, the Maharashtra State has been declared under section 33A of the Water (Prevention & Control of Pollution) Act 1974, and under section 31A of Air (Prevention & Control of Pollution) Act, 1981 respectively.

AND WHEREAS, it is obligatory on your part to obtain Consent from Board under provisions of the above-mentioned legislations. AND WHEREAS, it is obligatory on your part to comply those conditions and provide necessary water & air pollution control devices and operate them continuously and efficiently so as to meet the standards prescribed by the Board at all times.

AND WHEREAS, Hon'ble National Green Tribunal, New Delhi had passed an Order dtd. 08/05/2013 in Application No.37/2012 filed by Wassan Singh V/s State of Punjab, directing the concerned Pollution Control Boards and the Central Pollution Control Board, to file an Action Taken Report (ATR) in the Registry of the Tribunal within a period of three weeks and to ensure that all the procedures for sealing the illegally run/operated factories/units is immediately undertaken without waiting for any further Order.

AND WHEREAS, Board officials of Sub- Regional Office, Tarapur- II visited your industry on 02/08/2020 and vide ref. no. 3 reported following:

- 1. You are engaged in manufacturing in cotton socks and operating your unit without obtaining valid consent from MPC Board.
- 2. The noise monitoring carried out during visit found intensity of noise through your activity exceeding permissible limits.

AND WHEREAS, this amounts to blatant violation of above mentioned legislations, which shows your gross negligence attitude towards pollution control.

AND NOW THEREFORE, in the exercise of the powers conferred u/s 33A of Water (Prevention & Control of Pollution) Act 1974, and 31A of Air (Prevention & Control of Pollution) Act, 1981. I, Regional Officer, MPCB, Thane hereby directed to close down your manufacturing activities, within 72 hours taking all precautionary measures for safe closure, It shall be noted that competent authorities are hereby directed to disconnect your electricity and water supply.

In case of your failure to comply these directions, further suitable action which may be deem fit, as per the provisions of the Environmental Act's will be initiated against your unit, which may please be noted.
