**Sub :** Proposed Directions under Section 33(A) of the Water (Prevention and Control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981.

3. Proposal Submitted by Sub-Regional Office, Nagpur-II on 11/03/2024.

**WHEREAS,** the Maharashtra Pollution Control Board has granted Consent to Operate u/s 26 of the Water (Prevention and Control of Pollution) Act, 1974 and u/s 21 of the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under Rule 6 of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016.

**AND WHEREAS,** it is obligatory on your part to provide adequate pollution control devices and comply with the consent conditions to achieve the standards prescribed by the Board in consent.

**AND WHEREAS,** The M.P.C. Board official has visited your industry on 06/03/2024 for checking of compliance of consent conditions and investigation of complaint. Accordingly, Sub Regional Officer Nagpur-II has submitted proposal through legal module with mentioning non compliances i.e.

1. You have operating RMC Plant without obtaining consent to establish & operate from M.P.C. Board.
2. You have fail to regular cleaning and wetting of internal road resulting thick layer of dust found accumulated on internal and outside road which create heavy dust emission during vehicular movements which reduce visibility during transportation.
3. You have fail to provide fixed type water sprinkling arrangement beside internal roads for dust suppression resulting dust accumulated on surrounding inside and outside vegetations.

4. You have fail to provide proper two level tyre washing system along with to provision of ETP for treatment of generated effluent resulting sludge / mud is accumulated in internal and outside road which create dust emission.
5. You have fail to installed CAAQMS within premises of RMC Plant.
6. You have fail to provide closed shed for storage of aggregate and raw material as well as not provided closed covering to raw material feeding point which results the fugitive results in surrounding area.

**AND WHEREAS,** it seems that, you are knowingly and willingly causing the grave injury to the Environment by creating pollution in the nearby area.

**NOW THEREFORE,** considering the above non-compliance, you are hereby directed to show cause as to:

- 1) Why your industrial activities shall not be closed down forthwith ?**
- 2) Why the competent Authorities shall not be directed to disconnect water / electricity supply to your unit ?**

You are hereby given an opportunity to respond within 07 days from issuance of these directions and **directed to remain present in this office for a personal hearing on 20/03/2024 at 1:30 p.m. along with all necessary documents and compliance report.** failing which, MPCB will initiate legal action against your unit without giving any further notice in accordance with the provisions of the Water (prevention & Control of Pollution) Act, 1974 and Air (Prevention & Control of Pollution) Act, 1981.
