WHEREAS, it is obligatory on your part to obtain Consent to Establish and Consent to Operate from the Maharashtra Pollution Control Board under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 & Authorization under the provisions of the Hazardous and Other Wastes (Management and Trans-boundary Movement) Rules, 2016. It is also obligatory on your part to provide adequate pollution control devices.

AND WHEREAS, compliant was received against your industry. In order to verify the complaint or news, the officials of the Board at SRO Mumbai-II have visited the site at M/s. K. N. Dyers, Gala No 14/B/A, New India Market, opp. Rahmani Hotel, Kherani Road, Mumbai-400072 on 28/11/2022 and observed as follows:

- You have engaged in laundry activities & you have not obtained Consent to establish/operate from MPC Board.
- You have not provided Effluent treatment plant & untreated effluent is being discharged into environment.
- You have not obtained membership of CHWTSDF for scientific disposal of Hazardous waste.
- 4. You have not obtained local body NOC from Competent Authority.

AND WHEREAS, Board has issued Proposed direction on13/04/2023, in spite of giving sufficient opportunity, you have failed to submit the reply of the same. Which showing negligence attitude towards environment.

AND WHEREAS, after examining the record of your case, the reports of the officers of the Board, it has been observed that you are operating your unit without obtaining consent from the Board under the provisions of the Water (Prevention and Control of Pollution) Act, 1974 and the Air (Prevention and Control of Pollution) Act, 1981 and adequate pollution control devices, thereby pollution in the surrounding area.

NOW THEREFORE, in view of the above non-compliances, you are hereby directed to stop your manufacturing activities forthwith, failing which, the Board will have no option than to initiate appropriate legal action under the provisions of the Water (Prevention & Control of Pollution) Act, 1974 and the Air (Prevention & Control of Pollution) Act, 1981.
