WHEREAS you are operating your industry in 'Pollution Prevention Area' declared under Water (Prevention & Control of Pollution) Act, 1974, Air (Prevention & Control of Pollution) Act, 1981 & Hazardous Waste (M & TM) Rules, 2008 as amended.

AND WHEREAS it was obligatory on your part to obtain valid consent from the Board and to provide adequate water and air pollution control devices, so as to prevent any sort of pollution in the surrounding area and to achieve the standards laid down under the provision of Environment (Protection) Act 1986.

AND WHEREAS, Board officials visited your unit on 19.11.2022 as per ref no. (3) & observed following non compliances.

- 1. You have not renewed the MPCB's Consent to Operate which is expired on 31.05.2012 & operating your unit without valid consent from the Board.
- 2. You have not provided adequate measures to control foul smell. The unpleasant smell was noticed in & around factory premises, due to dead birds.
- You have not provided adequate full proof scientific storage for Poultry excreta. As
 it was found stored long time below the Poultry Birds area (basement) which results
 into formation & spreading of bad odour and heavy flies.
- 4. You have not provided adequate full proof scientific air pollution control arrangement so as to arrest & prevent spreading of foul smell in the surrounding areas. It is violation of Consent conditions.
- You have failed to submit reply of Warning Notice issued dated 22.11.2022 & non compliances still exits.
- 6. You have not obtained permissions of CGWA for pumping of ground water.
- You have failed to Comply with the conditions of Environmental Guidelines as stipulated for Poultry Farm issued by Central Pollution Control Board from time to time.



AND WHEREAS after examining the record of your case, reports of officers of the Board & making necessary enquiries, I am satisfied that you are causing Environmental Pollution problems in the surrounding area and knowingly & wilfully causing grave injury to the environment thereby violating various Environment enactments.

NOW, THEREFORE in exercise of the powers conferred upon me under Section 33A of the Water (Prevention & Control of Pollution) Act, 1974 & 31A of the Air (Prevention & Control of Pollution) Act, 1981, I, Jagannath Salunkhe, Regional Officer of the Board at Kolhapur hereby direct you to stop the manufacturing activity forthwith to avoid further damage to the surrounding environment and inform the same to this office immediately.
