WHEREAS, your unit is located in the "Pollution Prevention Area" under the Water (Prevention & Control of Pollution) Act, 1974, under the Air (Prevention & Control of Pollution) Act, 1981 and Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 and followed by further amendments made therein from time to time.

AND WHEREAS, the Board has granted the Consent to Operate to your unit under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974, under Section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Rule 5 of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 and amendments thereof. And it is obligatory on you provide pollution control system as it warranted and to operate and maintain the same continuously and effectively so as to achieve the standards prescribed in the Consent.

AND WHEREAS, the Board Office has received a complaint against your unit. Board Official of Nashik has visited to your unit on 20.04.2023 for investigation of compliant and checking compliance of Consent Conditions and made following non – compliance:-

- 1. You have provided STP for the treatment of Domestic sewage generated for your hotel activity, but during the visit same was not found in operation,
- During the visit you were found Discharging canteen effluent and domestic effluent into municipal sewer line.

- 3. You have provided OWC for biodegradable waste but during visit the same was also not in operation.
- 4. You have not provided the Scientific storage for biodegradable waste and non-biodegradable waste.

AND WHEREAS, the Board has already issued Show Cause Notice to you vide letter Dt-16.09.2022 for the non-compliances observed during the visit along with the CAG – Audit, **AND WHEREAS**, you have also been called for Personal Hearing on 30.09.2022 at 11:40 along with your reply, but you have neither attended the Personal Hearing nor submitted your reply, this shows your negligent attituded towards pollution control.

AND WHEREAS, in view of above non compliances Sub-Regional Officer Nashik has submitted legal action through legal module for initiation of legal action against your Hotel activity.

AND WHEREAS, the above non-compliances amount serious violations and clearly shows your gross negligent attitude towards pollution control.

AND WHEREAS, it seems that, your unit is habitual defaulter and you are knowingly and willingly causing the grave injury to the Environment in the nearby area.

NOW, THEREFORE, in exercise of the powers conferred upon the undersigned under section 33A of the Water (P&CP) Act, 1974 and Air (P&CP) Act, 1981 I, hereby issue Proposed Directions against your unit as follows:

- 1. Why your unit shall not be directed to stop the hotel activities henceforth.
- 2. Why the competent authority shall not be directed to disconnect water/electricity supply to your unit?

You shall remain present at this Office for personal hearing on 15.06.2023 at 02:00 P.M. along with yours say and present status of your unit with relevant documents failing which the Board will be constrained to issue appropriate final Directions as deemed fit in your case, which may please be noted.
