**Sub:** Closure Directions u/s 33A of the Water (P&CP) Act, 1974 & u/s 31 A of the Air (P&CP) Act, 1981 r. w. Hazardous & Other Wastes (M&TM) Rules, 2016.

**WHEREAS,** you are operating the industry in the pollution prevention area declared under the Provisions of the Water (P&CP) Act, 1974 and the Air (P&CP) Act, 1981 and the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

**AND WHEREAS,** it is obligatory on your part to obtain Conditional Combined Consent and Authorization to operate your industrial plant to discharge sewage and trade effluent in water pollution prevention area subject to certain terms and conditions more precisely under the provisions of 25/26 of the Water (P&CP) Act, 1974 and section 21 of the Air (P&CP) Act, 1981 and the Hazardous Waste (Management Handling & Transboundary Movement) Rules, 2016. **AND WHEREAS,** it was also obligatory on your part to provide adequate and efficient pollution control devices and take adequate measures to control air & water pollution from all sources so as to achieve the standards prescribed in the Environment (Protection) Act 1986 and to disposed the Hazardous Waste to CHWTSDF.


**AND WHEREAS,** Board has published Enforcement Policy vide under reference no. 1 to integrate various aspects including inspections, monitoring, standards, compliances, directions, remedial measures as per the provisions of the Environment (Protection) Act, 1986 and other Environmental Laws based on culpability environmental damages, severity of pollution, repeated violations etc.

**AND WHEREAS,** this office has received proposal from Sub-Regional Office, MPCB, Kalyan-I and reported following non- compliances.

- 1) You are operating unit without obtaining consent from MPC Board.
- 2) You have not provided effluent treatment plant (ETP) for treatment of trade effluent generating from process and untreated effluent found discharging directly into open land and nearby drain.
- 3) You have not provided air pollution control system to coal fired bhatti.
- 4) You have not obtained the membership of CHWTSDF for disposal of hazardous waste.

**AND WHEREAS**, after examining all the reports and records available with this office I have come to the conclusion that you are knowingly and willfully violating the provisions of the Water (P&CP) Act, 1974 and Air (P&CP) Act, 1981.

**NOW THEREFORE**, in exercise of powers conferred upon me by the Board u/s 33A of the Water (P&CP) Act, 1974 and u/s 31A of the Air (P&CP) Act, 1981. I, the Regional Officer, Kalyan hereby direct you to stop your manufacturing activity with immediate effect from receipt of this direction. It may also be noted that, the competent authorities are being directed to disconnect the electricity and water supply to your unit.
