**WHEREAS**, it is mandatory and obligatory on your part to abide the conditions stipulated under Consent to Operate granted by Maharashtra Pollution Control Board under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and Hazardous & Other Waste (Management, Handling & Transboundary Movement) Rules, 2016 for running your industrial activity at aforesaid location vide above reference cited at 1.

**AND WHEREAS**, the Hon'ble NGT has issued order 19.9.2019 in OA No. 400 of 2019 filed by Social Action for Forest and Environment (SAFE) Vs Union of India and Others.

**AND WHEREAS**, Board official visited to your industry on 06.12.2021 for checking the point wise compliance as per MoEF & CC SOP the Office Memorandum issued by MoEF & CC , Govt of India dtd 24/11/2015 for tyre pyrolysis units you are directed to comply the following directions:-




1. Screw conveyor system for carbon black is not provided and handling carbon black manually
2. You have not complied with the SOP issued by the MoEF & CC SOP dtd 24/11/2015.
3. You have not switchover your manufacturing activity from batch process to continuous process.

**AND WHEREAS**, after examining the record of your case and after making necessary enquiry this office has concluded that you are not complying with the consent conditions and violated the provisions made under various environmental enactments as well as causing pollution problem in the nearby surrounding area knowingly and wilfully.

**NOW THEREFORE**, in exercise of the powers confirmed upon me by the Board, I Dr.P.M Joshi, Regional Officer of the Board at Nashik hereby directed you to stop your production activity forthwith till further directions/order of the Board in a safe manner and the competent authorities are hereby also directed to disconnect electricity and water supply of your industry immediately, which may be noted.

This is issued with the post- facto approval of the competent authority of the Board.
