2. Personal Hearing extended to you on 26/04/2022.


The Board has issued Proposed Direction vide letter cited at ref. (1) to your industry under Section 33A of the Water (P& CP) Act 1974 and under Section 31A of the Air (P&CP) Act, 1981. As a principle of natural justice, a personal hearing was extended to you on 26/04/2022. During the course of personal Hearing, issues related with pollution problems of your industry were discussed in detail. Considering your assurances to improve Environment in your industry/ stone crusher, following Interim directions are issued under Section 33A of the Water (P & CP) Act, 1974 & 31A of the Air (P&CP) Act, 1981 for compliance.

1. You shall provide proper G.I. Sheet covering to vibrating screen and jaw crusher within 15 days.
2. You shall provide fix type water sprinkling arrangement within 15 days to premises of stone crusher
3. You shall provide metallic road to premises of stone crusher and approach road shall be metaled with water sprinkling arrangement within 15 days.
4. You shall provide Wind braking wall around stone crusher area within 02 Months.

5. You shall provide fix type water sprinkling arrangement at dust heap within 15 days, so as able to suppress dust which is generated during wind blow / wind velocity which may directly affect to nearby area/ agricultural land.
6. You shall provide covering on aggregate and dust carrying conveyer with provision of fogging system within 02 Months.
7. You shall undertake massive tree plantation around stone crusher during monsoon.
8. You shall submit Bank Guarantee of Rs. 50,000/- within 15 days towards compliance of Interim Direction.

In case, you fail to comply with the above Directions, the Board will have no option than to forfeit the Bank Guarantee and issue final directions as deemed fit in your case, along with suitable legal action which may please be noted.
