WHEREAS, it is mandatory and obligatory on your part to abide the conditions stipulated under Consent to Operate granted by Maharashtra Pollution Control Board under Section 26 of the Water (Prevention & Control of Pollution) Act, 1974 and under Section 21 of Air (Prevention & Control of Pollution) Act, 1981 and Hazardous & Other Waste (Management, Handling & Tran boundary Movement) Rules, 2016 for running your industrial activity at aforesaid location vide above reference cited at 1.

ANDWHEREAS, Board official visited the unit and observed non-compliances on 06.04.2022 vide above reference cited at. 2.


AND WHEREAS, proposal was received from SRO Ahmednagar, vide above ref. no. 3. Due to following non- compliances.

1. The industry is operating without valid consent from the Board from 31.08.2021.
2. The industry is not operating Effluent Treatment Plant regularly.
3. The industry is disposing untreated effluent directly on land for irrigation.
4. The industry is disposing white color untreated effluent on land.
5. The industry has not submitted Bank Guarantee of Rs. 50,000/- as per consent condition.

ANDWHEREAS, after examining the record of your case and after making necessary enquiry this office has concluded that you are not complying with the consent conditions and violated the provisions made under various environmental enactments as well as causing pollution problem in the nearby surrounding area knowingly and wilfully.

NOW THEREFORE, in exercise of the powers confirmed upon me by the Board, I Dr.P.M Joshi, Regional Officer of the Board at Nashik hereby directed you to stop your production activity forthwith till further directions/order of the Board in a safe manner and the competent authorities are hereby also directed to disconnect electricity and water supply of your industry immediately, which may be noted.

This is issued with the approval of the competent authority of the Board.
