This refers to proposed directions issued as referred (1) above and subsequent personal hearing extended on 23/09/2021. Considering recommendation from Sub Regional Officer Pune-I and your reply and re-presentation during the hearing, you are hereby directed to comply with the following Interim Directions,

1. You shall dispose all generated hazardous waste to CHWTSDF regularly as per the provision of Hazardous and Other Waste (M & TM) Rule, 2016.
2. You shall obtain amended consent with incorporate 05 Nos stack.
3. You shall connect OCEMS to MPCB and CPCB server within 01 months.
4. You shall submit the valid Bank Guarantee of Rs. 1,00,000/- (One Lakh Only) same will be forfeit against non-compliance noted in proposed directions or you shall submit the DD in favour of Regional Officer Pune for Rs. 1,00,000/- (One Lakh Only) against forfeiture amount of said BG.
5. You shall submit the Bank Guarantee of Rs. 5,00,000/- (Five Lakhs Only) as per existing consent of consent conditions.
6. The Bank Guarantees should be in favour of Regional Officer Pune and valid for a period of one year. You shall upload all the Bank Guarantees on MPCB Web – Portal by using your industry login ID and you shall submit original Bank Guarantees within 15 days alongwith online generated acknowledgement to this office.

In case you fail to comply with the above directions the Board will have no option than to issue appropriate directions as deem fit under the provisions of Water (P. & C. P.) Act, 1974 and under the provisions of Air (P. & C. P.) Act, 1981 & Hazardous & Other Waste (M & TM) Rules, 2016, which may please be noted.
