- ii) You shall not undertake re-processing of plastic contaminated with biomedical waste or plastic utilized for handling of biomedical waste, without necessary prior permission from the board.

In case of violation, the Maharashtra Pollution Control Board will revoke / suspend the registration and consent granted by the Board and will also take further legal action.

- 3) You shall comply with the directions given by the Municipal Corporation / Municipal Council i.e. local body.
- 4) This certificate of registration stands automatically cancelled, if any of the conditions stipulated above are found to be violated.
- 5) You shall apply for renewal of registration at least one hundred twenty days before the expiry of the validity of the registration certificate.
