- i. You shall prepare and submit annual report of plastic waste processing or recycling in Form-IV to the local body concerned under intimation to the concerned State Pollution Control Board or Pollution Control Committee by the 30th April, of every year.
- ii. You shall not undertake re-processing of plastic contaminated with biomedical waste or plastic utilized for handling of biomedical waste, without necessary prior permission from the board.

In case of violation, the Maharashtra Pollution Control Board will revoke / suspend the registration and consent granted by the Board and will also take further legal action.

3. You shall comply with the directions given by the Municipal Corporation / Municipal Council i.e. local body.
4. This certificate of registration stands automatically cancelled, if any of the conditions stipulated above are found to be violated.
5. You shall apply for renewal of registration at least one hundred twenty days before the expiry of the validity of the registration certificate.
6. This certificate is issued with the approval of Member Secretary of the Board.
7. You shall achieve 100% collect back system of post consumer plastic material equivalent to the plastic material introduced by you in the market, as your EPR plan.
8. You shall submit quarterly EPR compliance report to respective SRO Thane II, MPCB and UDD.
9. You shall not supply reprocessed plastic granules to producers (in formal / informal sector) engaged in production of banned items as per Maharashtra Plastic and Thermocol (Manufacture, Usage, Sale, Transport, Handling and Storage) Notification 2018 dated 23.3.2018 and amendment dated 11.4.2018, 30.6.2018 and 14.6.2019 and MoEF& CC single Use Plastic Notification 2021.
10. You shall ensure that supplier/ stockists / dealers and other entities engaged in your industry's supply chain do not supply plastic raw material to producers engaged in production of banned SUP items as per Maharashtra Plastic and Thermocol (Manufacture, Usage, Sale, Transport, Handling and Storage) Notification 2018 dated 23.3.2018 and amendment dated 11.4.2018, 30.6.2018 and 14.6.2019 and MoEF& CC single Use Plastic Notification 2021.
