- Product shall either be in natural shade which is without any added pigments or made using only those
 pigments and colorants which are in conformity with Indian Standard: IS 9833:1981 titled as "List of pigments
 and colorants for use in plastics in contact with foodstuffs, pharmaceuticals and drinking water", as amended
 from time to time:
- Products made of recycled plastic shall not be used for storing, carrying, dispensing or packaging ready to eat or drink food stuff
- The manufacturer shall not sell or provide or arrange plastic to be used as raw material to a producer, not having valid registration from the concerned State Pollution Control Boards or Pollution Control Committee;.
- The product used for packaging of food /edible items shall be more than 50 micron thickness with a minimum weight of 2 gm.
- 6. The manufacturers or seller of compostable plastic carry bags shall obtain a certificate from the Central Pollution Control Board before marketing or selling for this purpose.
 In case of violation, the Maharashtra Pollution Control Board will revoke / suspend the registration and consent granted by the Board and will also take further legal action.

7. Marking and labeling:

- A. Each product shall have the information printed in English or in local language thereon at the conspicuous part of each such packaging of the name & registration no. of the producer, thickness of Packaging with the mark of recycled, virgin or compostable as the case may be as per the Indian Standard: IS 14534:1998 and IS/ISO 17088:2008 Specification for Compostable Plastic and buy-back price.
- B. Each recycled product shall bear a label or a mark "recycled" as shown below and shall conform the Indian standard: IS 14534: 1998 titled as Guidelines for recycling of Plastics, as amended from time to time;



Note: PET – Polyethylene terephthalate, HDPE – High density polyethylene, V – Vinyl (PVC), LDPE – Low density polyethylene, PP – Polypropylene, PS – Polystyrene and Other means all other resins and multi – materials like ABS (Acrylonitrile butadiene styrene), PPO (Polyphenylene oxide), PC (Polycabonate), PBT (Polybutylene terephalate) etc.

- C. Product made from compostable plastics shall bear a label "Compostable" and shall conform to the Indian standard IS/ISO 17088: 2008 titled as specifications for compostable plastics.
- D. Protocols for the compostable Plastic materials Determination of degree of degradability and degree of disintegration of plastic material shall be as per the protocols of the Indian standard as prescribed in PWM rules, 2016 and amendment thereto.
- E. Compostable plastic bags or material used for plant nurseries, horticulture, agriculture, handling of solid waste shall be prominently printed on it with "Use exclusively for this specific purpose only".
- 8. You shall comply with the directions given by the Municipal Corporation / Municipal Council i.e. local body.
- This certificate of registration stands automatically cancelled, if any of the conditions stipulated above are found to be violated.
- 10. You shall apply for renewal of registration before 120 days of expiry of registration.
- 11. This is issued with approval of the competent authority of the Board.

- 3. You shall achieve 100% collect back system of post consumer plastic material equivalent to the plastic material introduced by you in the market, as your EPR plan.
