LETTER OF BIO-MEDICAL WASTE AUTHORISATION

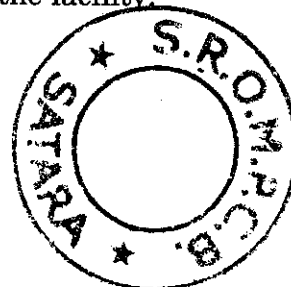
(Authorization for operating a facility for generation, storage & disposal of Bio-Medical Waste)

- I) M/s.Nilprabha Clinic, Dr.Prabhakar Baburao Bhoite, Plot No.74, Shivajinagar, Phaltan, Tal-Phaltan, Dist- Satara (05 Beds) is hereby granted an authorization of handling of bio- medical waste on premises located at above address.
- II) This authorization shall be in force for a period up to 31/03/2023. 
- III) An application shall be made by the occupier/operator for renewal 30 days before expiry of earlier authorization.
- IV) This authorization is issued subject to compliance of the condition stated below & to such other conditions as may be specified in the Rules for the time being in force under the Environment (Protection) Act, 1986.

Terms & Conditions of Authorization

- 1) The authorized person shall comply with the provisions of the Environment (Protection) Act, 1986 & the Rules made there under.
- 2) The authorization shall be produced for inspection at the request of an officer authorized by the prescribed authority.
- 3) i) The authorized person shall not rent, lend or sell the bio medical waste or facility.
ii) The authorized person shall transfer the BMW generated at above premises to the "Transporter" or "Operator of Facility" promoted by Municipal Council Corporation authorized by MPCB under Bio-Medical Waste (Management & Handling) Rules, 1998 for collection, transportation, treatment & by deep burial method as per BMW (M&H) Rules, 1998. Any unauthorized change in equipment or working conditions as mentioned in the application by the person authorized shall constitute a breach of this authorization.
- 4) It is the duty of the authorized person to take prior permission of the prescribed authority to close down the facility.

- 5) The combined consent is granted for generation and disposal of Bio-Medical Waste (BMW) in waste categories and quantities listed here in below:

<p>No onsite treatment of BMW is permitted. The above mentioned Bio medical Waste shall be sent to Common BMW Treatment & Disposal facility i.e. M/s. Jai Bhavani Bio-Medicare Systems, G-170, MIDC Baramati, Dist-Pune authorized by MPCB.</p>					

- 6) The liquid waste generated from the hospital (from laboratory & washing, cleaning, housekeeping & disinfecting activities) shall be treated suitably to conform to the standards prescribed in schedule V of said rules & the Environment (Protection) Act, 1986.
- 7) (i) BMW shall be treated & disposed of in accordance with Schedule - I & in compliance with the standards prescribed in Schedule V of the said Rules.
- 8) (i) BMW shall not be mixed with other wastes or reused, recycled or sold in any form.
- (ii) BMW shall be segregated into containers/bags at the point of generation in accordance with Schedule - II prior to storage, treatment & disposal. The containers shall be labeled according to Schedule - III.

- (iii) If a container containing BMW is to be transported from the premises where BMW is generated to any waste treatment facility outside the premises, the container shall, apart from the Label prescribed in Schedule – III, also carry information prescribed in Schedule – IV & shall be transported by Authorized Transporter only.
- (iv) Notwithstanding anything contained in the Motor Vehicles Act, 1988, Rules, Or rules there under, BMW shall be transported only in such vehicle as may be authorized for the purpose by the competent authority as specified by the Government.
- (v) No untreated BMW shall be kept stored beyond a period of 48 hours.
- 9) Every "Authorized Person" shall submit any Annual Report to the prescribed authority in Form – II by 31st January every year including information about the categories & quantities of BMW handled during the preceding year.
- 10) (i) Every authorized person shall maintain records related to the generation collection, reception, transportation, treatment, disposal & or any form of handling of BMW in accordance with these Rules & any guidelines issued.
- (ii) All records shall be subject to inspection & verification by the prescribed authority
- 11) When any accident occurs at any institution or facility or any other site where BMW is handled or during transportation of such waste, the authorized person shall report the accident in Form – III to the prescribed authority forth with.
- 12) The Occupier will obey all the lawful instructions issued by the Board Officers from time to time.

Statement of conditions to be complied and Bank Guarantee imposed to ensure timely compliance to be observed by hospital.


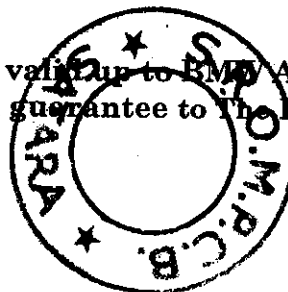

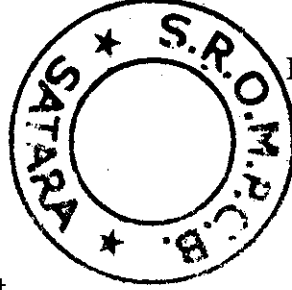
