- Industry shall comply with the specific standards notified under environment protection act.

Industry shall obtained Authorization / Registration and submit modalities for waste collection system based EPR approved by UDD, action plan for setting of Plastic Waste Management System under Plastic Waste Management Rules, 2016 as per Rules no. 9 & Plastic Notification 23/03/2018 and amendment thereof.. within 01 Months after approval from UDD submit quarterly report to this office. (If Applicable)
8. The industry shall obtain necessary permission from the Directorate of Industrial Safety and Health (DISH) as per Circular dtd 24/03/2021.
