**AND WHEREAS,** Board has issued Show cause Notice vide ref. no.3 for following non-compliances

1. You have not specified the type of other wastes ( as per Part D of Schedule-III Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016) and qty of each type of waste(s) to be imported.
2. You have not submitted details of actual user for re-processing of waste to be imported.
3. You have not submitted copy of consent to operate of actual user.
4. You have not submitted copy of authorisation of actual user for re-processing of non-ferrous waste to be imported.
5. You have not submitted MOU with actual user. Please submit the properly validated MOU with name, designation, seal/ stamp of authorised signatory.
6. You have not submitted storage details of imported waste.
7. You have not submitted copy of Import/ Export certificate, GST certificate.


**AND WHEREAS,** you have failed to submit reply to the Show Cause Notice even after lapse of considerable time period.

**NOW THEREFORE,** your application for grant of Authorisation for Import of Metal Scrap 8000 MTA under (Part-D of Schedule-III) on behalf of actual user is hereby refused as per the provisions of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

You may prefer on appeal against refusal of authorisation passed by the State Pollution Control Board may, within a period of thirty days from the date on which the order is communicated to him, prefer an appeal in Form 12 to the Appellate Authority as per the provisions of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.
