WHEREAS, this office is in receipt of your application for grant of Amendment in Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, the amendment sought by you for a change in the product mix and an extension of the validity period does not fall within the scope of the amendment criteria prescribed under Board Circular No. BO/MPCB/AS(T)/Circular/B-39 dated 25/08/2025.

In view of above, your application for grant of Amendment for Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances.
