WHEREAS, this office is in receipt of your application for grant of Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, you have submitted an application for grant of amendment in Consent to Operate for change of name from "M/s. Hotel Silverene" to "M/s. Silverene Restaurant" under Section 26 of the Water (Prevention and Control of Pollution) Act, 1974, Section 21 of the Air (Prevention and Control of Pollution) Act, 1981, and for amendment in Authorization under the Hazardous and Other Wastes (Management and Transboundary Movement) Rules, 2016.

AND WHEREAS, as per the Board Circular dated 25/08/2025 regarding amendment of Consent applications, you have failed to submit the Incorporation Certificate, which is a requisite document for processing the application. In the absence of the said document, the Board is unable to verify the legal status of the unit and take an appropriate decision regarding the grant of amendment in Consent to Operate.

In view of above, your application for grant of amendment in Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above noncompliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
