Sub: Cancellation of application of registration under the Plastic Waste Management Rules, 2016.

- Ref: 1) Your application No. MPCB-PLASTIC\_MANF-000000255 for grant of Registration under PWM rules 2016 received through Sub Regional Officer, MPCB, Ahmednagar.  
2) Show Cause Notice issued vide no. MPCB/RO(HQ)/Plastic (regis)/B-2004 dated 13.6.2019  
3) Minutes of 8<sup>th</sup> Meeting of Committee constituted for decision on grant /refusal of registration dtd 1.10.2020 and subsequent approval on office note in May, 2021.

**WHEREAS**, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for as Producer for mfg of blown films vide reference No.1.

**AND WHEREAS**, as per rule 9(2) of Plastic Waste Management (Amendment) Rules, 2018, "Primary responsibility for collection of used multi-layered plastic sachet or pouches or packaging is of Producers, Importers and Brand Owners who introduce the products in the market. They need to establish a system for collecting back the plastic waste generated due to their products."

**AND WHEREAS**, as per rule 13(6) of Plastic Waste Management (Amendment) Rules, 2018, "The State Pollution Control Board or the Pollution Control Committee shall not renew registration of producer unless the producer possesses and action plan endorsed by the Secretary in charge of Urban Development of the concerned State or Union Territory for setting of plastic waste management system."

**AND WHEREAS**, Government of Maharashtra has published Maharashtra Plastic and Thermocol Products (Manufacture, Usage, Sale, Transport, Handling and Storage) Notification, 2018 which entails the ban on all plastic and thermocol products except for certain items subject to conditions specified thereof.

- AND WHEREAS**, during scrutiny of your application following lacunae are observed
1. You have not obtained amendment in Consent to Operate in accordance with the Maharashtra Plastic Notification 2018 and amendment thereto.
  2. You have not submitted the above said action plan even after lapse of considerable time period.
  3. SRO-Ahmednagar reported that your unit is permanently closed.

**AND WHEREAS**, you have failed to submit satisfactory reply to the Show Cause Notice issued by MPCB vide ref. no.2.

**AND WHEREAS**, in line with the decisions taken in meeting of the committee constituted for deciding guidelines/ examination for issuance of Registration to Producer/ Recycler/Brand-owners under Plastic Waste Management Rules, 2016, your application was put up before the competent authority for further decision in your case and it was decided to issue Cancellation of registration application for above non-compliances.

In view of the aforesaid non-compliance, your application for grant of registration is hereby cancelled under the provisions of the Plastic waste Management Rules, 2016 and you are hereby directed re-apply and not to carry out operation activities without obtaining registration and amendment in consent to operate( in compliance with Maharashtra Plastic Notification, 2018), failing which the Board will have no option then to initiate further legal action against you, which please note.
