Sub: Refusal of application for registration under Hazardous Waste Transportation under Hazardous Waste & Other Waste (Management & Transboundary Movement) Rules, 2016.

Ref: 1) Your application No. MPCB-HW_TRANSPORT-0000000524 received from the Sub Regional Officer, MPCB Kalyan-I.

WHEREAS, you have made application for the grant of authorization under rule 18(7) of the Hazardous Waste & Other Waste (Management & Transboundary Movement) Rules, 2016 it is mentioned that “The authorization for transport shall be obtained either by the sender or the receiver on whose behalf the transport is being arranged”.

AND WHEREAS, Board has issued public notice in daily News Paper Loksatta and Indian Express on 25/03/2021 for intimation about hazardous waste transport rule and submission of memorandum of understanding (MOU or MoU) between Transporter and Generator / Receiver of Hazardous waste.

AND WHEREAS, Board has received your application for “The vehicle number **NL01AF0878 & NL01AF0879**” for grant of Authorisation for Hazardous waste Transportation under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016. **AND WHEREAS**, the Board has issued Show Cause Notice dtd. 23-10-2024 for non-payment of Rs. 5000/- for HW Transport authorisation as per Circular dated 30-1-2024 and MoU between Transporter and Generator / Receiver of Hazardous waste, however you have failed to submit the reply of SCN & you have not submitted/ paid authorization fees of Rs. 5000/- & MoU between Transporter and Generator / Receiver of HW till date even after reasonable opportunity given to you for the submission of aforesaid information.

In view of above, your application for grant of authorization vide no. **MPCB-HW_TRANSPORT-0000000524** for transportation of Hazardous Waste is hereby refused.
