AND WHEREAS, the Board office has granted Renewal of Consent to Operate vide dated 23/03/2026 reference (1). You have submitted application for Increase in Hazardous Waste quantities, and addition of non-hazardous i.e. Waste Electrical waste & Empty Disposal Barrels

AND WHEREAS, your amendment application is not in accordance with the Board's Circular dated 25.08.2025 as above reference (2)
