WHEREAS, this office is in receipt of your application for grant of Amendment in Consent to Operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, you have applied for amendment in consent to operate for change in category from Green to Orange. However, M/s. Runwal My City has informed for discontinuation of buying of RMC material from the M/s. ACC but they have not mentioned from exact which plant they are discontinuing to purchase the material. AND WHEREAS, you are directed to apply through regular consent application process.
