WHEREAS, this office is in receipt of your application for grant of Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, the Board has granted renewal of Consent to Operate to the unit, valid up to 30.09.2029, for baling of non-hazardous scrap, granules, and corrugated boxes. Now applied for amendment in the existing consent for inclusion of additional products, namely Aluminium scrap, Copper scrap, Cast Iron, and Leather scrap (10 T/month). Metal scraps such as Aluminium scrap and Copper scrap fall under Hazardous Waste, and therefore are not covered under the existing non-hazardous activity.
