WHEREAS, this office is in receipt of your application for grant of Amendment in Consent to Establish under section 25 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, Board has issued circular vide dated 25/08/2025 stating that following reasons shall be considered valid for submission of amendment applications in Consent. Only Typographical or clerical errors in the consent issued to the industry, Change in the name of the industry (subject to supporting documentary evidence) & Change in the disposal path of Hazardous Waste for pre-processing or coprocessing, as per the policy of the Board.

AND WHEREAS, You are directed to submit the regular application for consideration with mandatory documents, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Amendment in Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
