Condition no : 5

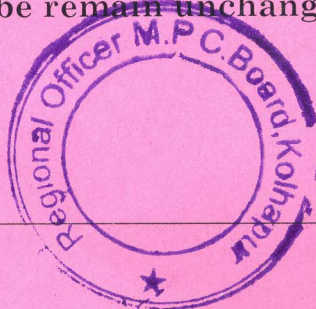
- (i) **B) Standards for Stack Emissions of Air Pollutants:**

- (ii) The applicant shall observe the following fuel pattern:-

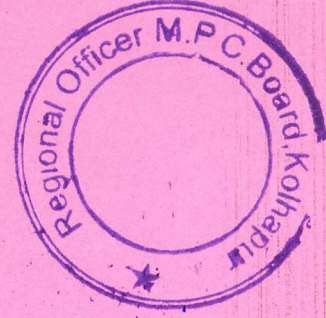
