WHEREAS, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for as Producer for mfg of HDPE AND LDPE COVER (ABOVE 150 MICRON THICKNESS ONLY CUTTING AND STITCHING ACTIVITY) vide reference No.1.

AND WHEREAS, you have obtained consent to operate dated 8.7.2019 for manufacturing of LDPE & HDPE cover (above 150 micron thickness) only cutting and stitching.

AND WHEREAS, as per rule 13(1) of Plastic Waste Management (Amendment) Rules, 2018, "No person shall manufacture carry bags or recycle plastic bags or multi-layered packaging unless the person has obtained a registration from the State Pollution Control Board or the Pollution Control Committee of the Union Territory concerned, as the case may be, prior to the commencement of production".

AND WHEREAS, in line with the decisions taken in meeting of the committee constituted for deciding guidelines/ examination for issuance of Registration to Producer/ Recycler/Brand-owners under Plastic Waste Management Rules, 2016, your application was put up before the competent authority for further decision in your case and it was decided to directly issue Cancellation of registration application as the products may not require registration.

In view of the aforesaid non-compliance, your application for grant of registration is hereby cancelled under the provisions of the Plastic waste Management Rules, 2016 and you are hereby directed re-apply (if registration applicable), failing which the Board will have no option then to initiate further legal action against you, which please note.
