The applicant shall not use plastic and plastic packaging material, which are banned as per the provision of Maharashtra Plastic & Thermocol Products (Manufacture, Usage, Sale, Transport, and Handling & Storage) Notification 2018 and further amendments and also comply with the provisions of the Plastics Waste Management Rules, 2016 and further amendments.
6. The applicant shall obtain necessary permission from the Directorate of Industrial Safety and Health (DISH), in case of store /handle/ process the Hazardous Chemicals.
7. The applicant shall strictly comply with Board's Circular vide No. MPCB/JD(APC)/NCAP/DG Set/B-0090 dtd. 02/06/2023 regarding Retrofitting of Emission Control Device (RECD) for in-use Diesel Operated Internal Combustion Engines/D.G. Sets.
