WHEREAS, this office is in receipt of your application for grant of Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, the Board office has granted Renewal of Consent to Operate vide dtd. 06/11/2025 reference (1). You have submitted application for change Sulphur Content (in %) 0.5 % & 1200 Kg/Day to 1.0 % & 2400 Kg/Day.

AND WHEREAS, your amendment application is not in accordance with the Board's Circular dtd. 25.08.2025 as above ref.(2)

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
