WHEREAS, this office is in receipt of your application for grant of Consent to operate (renewal) under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board has issued circular dtd. 25/08/2025 wherein it is mentioned that only following reasons shall be valid for submission of amendment application in consent: 1) Typographical or clerical errors in the consent issued to the industry.2) Change in the name of the industry (Subject to supporting documentary evidence) 3) Change in the disposal path of Hazardous Waste for pre-processing or Co-processing.

AND WHEREAS, you have reapplied for consent to renewal vide application No. MPCB-CONSENT-0000283565, for the said activity and hence your request for amendment of this consent application shall not be considered.

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances.

If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
