WHEREAS, this office is in receipt of your amendment application for grant of Consent to Operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, During processing it is observed that industry has submitted amendment application for change Plot No i.e from J -16 to J- 13 which is not covered in amendment scheme as per Board Circular No. BO/MPCB/AS(T)/Circular/B-39 Dated. 25.08.2025

AND WHEREAS, Change in address is not covered in amendment scheme as per Board Circular No. BO/MPCB/AS(T)/Circular/B-39 Dated. 25.08.2025

In view of above, considering the above noncompliance, your amendment in application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981. You are hereby directed not to take any effective steps towards operation of the unit without permission of the Board, else Board will initiate legal action as per the provisions of Environmental enactments.
