



**WHEREAS**, you have made an application in form no. 1 for obtaining authorization for **Import of WASTE TYRE SCRAP** under the provisions of Hazardous & Other Wastes (M & TM) Rules 2016.

**AND WHEREAS**, It was noted that you have applied for **Import of WASTE TYRE SCRAP**.
