WHEREAS, you have made application for grant HW Authorization under Rule (6) of Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016 for DISTILLATION OF SPENT SOLVENTS at above site address vide reference No. 1.

AND WHEREAS, Board has issued you Scrutiny Letter vide Ref. (3) for the following non-compliances: You have not installed VOC media analyzer. Fixed pipelines are not provided to settling tanks. ETP upgradation was not done and Operation & Maintenance of ETP was found poor. You have not attended the HW authorization committee meeting held on dtd. 05.07.2024.

AND WHEREAS, you have not submitted reply to the show cause notice for refusal along with the mandatory information and / or documents. Your application was discussed in the 4th Meeting of HW Authorization Committee held on 22.11.2024. The Committee decided to issue Show Cause Notice for the above non-compliances. Accordingly, the Board has issued Show Cause Notice vide Ref. (3). However, you have not submitted the reply to the Show Cause Notice and thus failed to submit the mandatory information and / or documents for processing of your application.

THEREFORE, your application for grant of HW Authorization is hereby refused under Rule (7) of the Hazardous and Other Wastes (Management & Transboundary Movement) Rules, 2016. If you are aggrieved by this order, you may prefer an appeal before the competent authority within 30 days from the receipt of this order.
