Sub: Refusal of amendment in Consent to Establish under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981.

WHEREAS, Board has granted Consent to Establish vide under reference no. 1 with certain terms and conditions stipulated therein.

AND WEHEREAS, you have applied for grant of amendment in Consent to Establish w.r.t. change in capital investment from Rs. 82.00 Cr. to 150 Cr. under the provisions of Section 25 of the Water (Prevention and Control of Pollution) Act, 1974; under Section 21 of the Air (Prevention and Control of Pollution) Act, 1981 and Hazardous & Other Wastes (Management & Transboundary Movement) Rules 2016.

AND WHEREAS, Your application for grant of amendment in Consent to Establish with respect to change in Capital Investment (CI) was placed before the 10th Consent Committee Meeting held on 22/07/2026.

AND WHEREAS, during the meeting, the Committee observed that at the time of submission of the Consent to Establish application bearing UAN No. 0000270887, you had submitted two (02) undertakings indicating a Capital Investment of Rs. 82.00 lakh, comprising Land & Building, Plant & Machinery, and Furniture & Fixtures. You had also submitted a Chartered Accountant's Certificate indicating a Capital Investment of Rs. 68.00 crore, comprising Plant & Machinery and Furniture & Fixtures. Further, it was observed that along with the present amendment application, you have submitted an undertaking indicating a Capital Investment of Rs. 68.00 crore only.

AND WHEREAS, the Committee further observed that no documentary evidence or supporting records have been submitted to substantiate the Capital Investment of ₹150.00 crore claimed in the application. Therefore, you are required to submit documentary evidence in support of the claimed Capital Investment for further consideration of your application. Therefore it was decided to issue Refusal of amendment in Consent to Establish.

In view of above, your application for grant of amendment in Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
