WHEREAS, this office is in receipt of your application for grant of Consent to Establish under section 25 of the Water (Prevention & Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

AND WHEREAS, Board office has issued scrutiny letters vide reference (2) above in which asked to submit the information regarding 1) Valid membership of CBMWTF i.e. M/s. SMS Envoclean, Deonar for disposal of biomedical waste generated. 2) You have carried out only sample collection activity & there is no sample testing activity. 3) You have applied for CCA in non-bedded category vide application no. MPCB-BMW_AUTH-0000048017 & same was auto granted by the Board dtd. 02/04/2023 valid up to 02/03/2026 with subject to having valid membership of Common BMW Treatment Facility in the jurisdiction authorized by MPCB.

AND WHEREAS, you have failed to submit the reply to the letter even sufficient & reasonable opportunity given for the submission of same and in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
