**WHEREAS,** you have applied for grant of Authorisation for import of RECYCLABLE, OLD CORRUGATED CARTONS (HS CODE 47071000) 120 TON PER YEAR (Part-D of Schedule-III) for trading activity under Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.

**AND WHEREAS,** Board has issued Show cause Notice vide ref. no.3 for following non-compliances

1. You have not replied to SRO's scrutiny letter stating i) *You shall submit details of waste collected from and consent copy of the dealer & MOU between your company dealer and end-user.* ii) *You shall submit local body NOC.* iii) *You shall submit land/ plot ownership documents.*
2. You have not submitted copy of consent to operate of actual user.
3. You have not submitted MOU with actual user. Please submit the properly validated MOU with name, designation, seal/ stamp of authorised signatory on Rs. 100 stamp paper as per MPCB's prescribed format.
4. You have not submitted, whether the imported corrugated carton waste is mixed with hazardous waste.
5. You have not submitted storage details of imported waste.

**AND WHEREAS,** you have failed to submit reply to the Show Cause Notice even after lapse of considerable time period.


**NOW THEREFORE,** your application for grant of Authorisation for Import of RECYCLABLE, OLD CORRUGATED CARTONS (HS CODE 47071000) 120 TON PER YEAR under (Part-D of Schedule-III) on behalf of actual user is hereby refused as per the provisions of the Hazardous & Other Wastes (Management & Transboundary Movement) Rules, 2016.
