AND WHEREAS, the Board office has granted Renewal of Consent to Operate vide dtd. 06/10/2025 reference (1), you have applied for amendment for Consent Subject i.e instead of Raw material name only Molasses add Cane Juice and Sugar syrup.

AND WHEREAS, your amendment application is not in accordance with the Board's Circular dtd. 25.08.2025 as above ref.(2)

In view of above, your application for grant of Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances.
