WHEREAS, you have made an application for grant of registration as per rule 13 of the Plastic Waste Management Rules, 2016 for recycling of Plastic waste vide reference No.1.

AND WHEREAS, as per sub-rule (5) of the rule 13 of the Plastic Waste Management Rules, 2016, it is mandatory on your part to possess valid consent under the Water (Prevention and Control of Pollution) Act, 1974 (6 of 1974) and the Air (Prevention and Control of Pollution) Act, 1981 (14 of 1981) along with a certificate of registration issued by the District Industries Centre or any other Government agency authorised in this regard for recycling or processing of plastic waste.

AND WHEREAS, as per sub-rule 7 of the rule 13 of the Plastic Waste Management Rules, 2016, "On receipt of the application complete in all respects for the registration for recycling or processing of plastic waste under sub-rule (3), the State Pollution Control Board may, after such inquiry as it considers necessary and on being satisfied that the applicant possesses appropriate facilities, technical capabilities and equipment to handle plastic waste safely, may grant registration to the applicant on fulfilment of the conditions as may be laid down in terms of registration."

AND WHEREAS, SRO-Thane-II has reported that you have obtained Consent to Establish for mfg of plastic granules from plastic scrap -1000 Kg/day on Sr. no. 159, however you have applied for Sr. no. 160.

AND WHEREAS, Board has already issued Show Cause Notice and Refusal letter vide ref. no.2. for site at Sr No 150, Wakanpada Vasai Fata, Vasai (East), Vasai 401208 (in respect of application no. MPCB-PLASTIC_MANF_RC-0000000108) as you have obtained only Consent to Establish dtd 21.9.2019 but not Consent to Operate and the address in MSME registration mentions location of your unit as Goregaon (east) whereas the application of registration and consent to establish mentions site address as Vasai (east) Palghar

In view of the aforesaid, your application for grant of registration as Recycler is hereby cancelled / not considered by Maharashtra Pollution Control Board under the provisions of the Plastic waste Management Rules, 2016.
