WHEREAS, this office is in receipt of your application for grant of Amendment in Renewal Consent to operate for Change in name of industry under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, you have submitted only lease deed agreement copy towards change in name of industry and not submitted copy of Certificate of Registrar of Companies (ROC) letter towards change in name of industry, which is insufficient (documentary evidence for change in name industry).

AND WHEREAS, in the absence of the desired information, the Board is unable to take decision about grant of Amendment in Consent to operate for change in name of industry.

In view of above, your application for grant of Amendment in Renewal of Consent to Operate for change in name industry is hereby refused under Section 27 of the Water(Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 days' time from the date of receipt of this letter.
