7. Industry shall comply with the provision of Maharashtra Plastic and Thermocol Products (Manufacture, Usage, Sale, Transport and Handling and Storage) Notification, 2018 and amendment thereof.
8. This consent has been issued subject to "The industry shall comply with the Government Resolution published vide dated 29/01/2025 issued by Revenue and Forest Department, Government of Maharashtra." As per Boards Circular dated 28/11/2025.
