AND WHEREAS, the Board office has granted Consent to Establish (Expansion) vide dtd. 14/04/2026 reference (1). You have submitted application for removal of the conditions prescribed at sr. no. 15 i.e. "The applicant should not take any effective steps for implementation of the project before obtaining Environmental Clearance as per the EIA Notification, 2006 and its amendments for BUA of 63430.377 sq. mtrs."

AND WHEREAS, your amendment application is not in accordance with the Board's Circular dtd. 25.08.2025 as above ref.(2)

AND WHEREAS, you have failed to submit the reply to the letter even sufficient & reasonable opportunity given for the submission of same and in the absence of the desired information, the Board is unable to take decision about grant of consent.

In view of above, your application for grant of Consent to Establish is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
