You have obtained Renewal consent to operate vide Format1.0/SRO/UAN No.MPCBCONSENT-0000238935/CR/2504002038 Dated 17/04/2025. Said consent valid up to 31/03/2028. Therefore this old amendment application is hereby refused as you have obtained subsequent renewal of consent.

As per Board's circular Dtd. 25/08/2025 amendment application shall be considered for typographical or clerical errors in the consent issued to the industry and change in the name of the industry and change in disposal path of hazardous waste for pre-processing or co-processing only. Your application do not fit for grant of amendment as per MPCB circular Dtd.25/08/2025.
