

1. The NOC is subject to the conditions stated below and sub conditions as may be specified in the rules in force under the Environment (Protection) Act, 1986.
2. The material shall be handled, transported & disposed as per provisions of the Hazardous & Other Wastes (M&TM) Rules, 2016.
3. You shall follow manifest system as per 19(1). You shall maintain all the necessary records & submit it to this office along with copy to concerned Regional Office / Sub Regional Office.
4. The material shall be transported through authorized HW Transporter.
5. All the necessary care shall be taken while disposing at CHWTSDF. The cost of restoration or remediation, if any shall be incurred from M/s. S G Pharma Pvt. Ltd., 542, 3/10, Bhuta Niwas, Dr. Ambedkar Road, Matunga (E) Mumbai for any damage caused to the environment resulting due to improper handling, transport, treatment & disposal of said material.
6. The destruction shall be carried out as per proper legal and scientific procedure.
7. The NOC is granted for disposal of **10 MT** of date expired, discarded and off specification Drugs/Medicines by way of **Incineration** as per the Hazardous & Other Wastes (M&TM) Rules, 2016, at Common Hazardous Waste Treatment Storage & Disposal Facility (CHWTSDF) i.e. MWML, Taloja.
