WHEREAS, this office is in receipt of your application for grant of amendment in Consent to operate under section 26 of the Water (Prevention of Control of Pollution) Act, 1974 & under section 21 of the Air (Prevention & Control of Pollution) Act, 1981 and Authorization under Hazardous & Other Wastes (Management & Transboundry Movement) Rules, 2016.

AND WHEREAS, the PP has applied for release of the existing Bank Guarantee of Rs. 10.00 lakh under the Board Circular dated 25/08/2025 regarding amendment in consent. However, the request for release of the existing BG does not fall within the scope of amendment in consent covered under the said Circular. Hence, the application cannot be considered under the provisions of the said Circular.

In view of above, your application for grant of amendment in Consent to Operate is hereby refused under Section 27 of the Water (Prevention & Control of Pollution) Act, 1974 and Section 21 (4) of the Air (Prevention & Control of Pollution) Act, 1981 for the above non-compliances. If you are aggrieved by this order, you may prefer an appeal as per provision in the Water (P&CP) Act 1974 & the Air (P&CP) Act 1981 within 30 day's time from the date of receipt of this letter.
